### What is Project One?



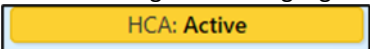

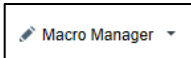



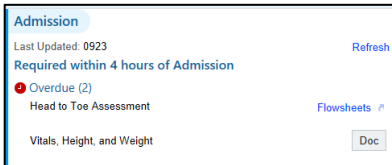
### Why a Special Edition Newsletter?

 New Feature  Time Saver	Macros	Documentation Efficiency	<ul style="list-style-type: none"> <li>System macros (6) in Navigators allow commonly documented answers to populate documentation with one click. Macros are named to describe the action of the macro.</li> <li>Hover on a macro name to see the default responses highlighted in the form.</li> <li>Click the macro button and all the answers flow in. Edit answers as needed.</li> <li>Personal Macros can be created in navigators and Flowsheets. Look for the macro manager button in your navigator section toolbar or flowsheet toolbar.</li> </ul> 
 Quick Win	Banners and BPAs	Less Interruption of Workflow	<ul style="list-style-type: none"> <li>Banners and BPAs have been reevaluated, rewritten, and, in some cases removed.</li> <li>Banners are to provide more purposeful wording and direction.</li> <li>BPAs are to be sent to the right person at the right time.</li> </ul>
 Workflow	Navigators	Standardized Documentation	<ul style="list-style-type: none"> <li>Travel Screening has updated questions with a fresh look and feel. Click the link to open.</li> <li>Less interruptive BPAs. Listed at the bottom of navigator to finalize the admission process.</li> <li>Elopement/Abduction screening slimmed-down.</li> <li>Skin and Fall Assessments listed separately.</li> <li>Belongings is updated, and the Print Belongings section has been removed.</li> <li>Health Care Agent added to enter the person(s) chosen and their role in carrying out medical decisions.</li> <li>Global immunizations have been renamed Vaccine Assessments.</li> </ul>

View and act on required documentation.</li> </ul>
